**Please read before joining.**

Three types of memberships are available: **Regular**, **Associate**, and **Student**. Annual dues for **Regular** and **Associate members** is **\$125** per person. **Quarter payment** available for \$35.00 per quarter. **Student membership** is **\$60**.

All Members receive the following **benefits**:

- **Four dollars off** the price of most **group classes** and dance parties.
- **Two dollars off** the price of daily floor **practice fee**.
- Approximately **30%** off the price of **workshops** and **special events**.
- **Free group classes** as indicated on the schedule.
- **Free dance parties** as indicated on the schedule.
- Birthday members attending the birthday night party are entitled to bring **one FREE guest** to the class and party as indicated on the schedule.
- **Free cake** for all, plus a souvenir birthday **picture** for each birthday baby.
- Eligibility to become a Host and receive Host benefits.

**Associate Members** may become **Regular Members** by volunteering at least five (5) hours of committee work annually. **Regular Members** in good standing for 12 consecutive months have the right to vote. **Regular Members** in good standing for 24 consecutive months may run for Board of Directors, will be invited to the Annual Recognition Dinner-Dance for volunteers. **Members who elect quarterly payments** do not have grace period; renewal payments must be paid on or before the end of the quarter date paid.

The Allegro Ballroom is owned and operated by Allegro Dancers, Inc., a CA501c3 non-profit, public-benefit Dance Club that promotes ballroom dancing education and is eligible for tax-deductible contributions both monetary and in-kind.
